

THIS COURT ORDERS that:


1. 2. The Plaintiff is granted leave to amend the Notice of Civil Claim in this proceeding as set out in the attached **Schedule "A"**;
3. Any amendment is without prejudice to the defendants' right to raise a limitation defence at trial;
4. The time within which any party may file a response to the Amended Notice of Civil Claim be 28 days from the date this Order is pronounced; and
5. The requirement for signatures of counsel is dispensed with.
