THIS COURT ORDERS that:

1. This Court does not have jurisdiction over claims against the Surrey Defendants brought by current Surrey Police Service officers below the rank of inspector, which claims arose on or after March 10, 2022.
2. This Court does not have jurisdiction over claims against the Surrey Defendants brought by current Surrey Police Service officers at the rank of inspector, which claims arose on or after September 26, 2024.
3. Whether the Court retains jurisdiction over claims against the Surrey Defendants brought by Surrey Police Service officers who are no longer employed by the Surrey Police Board is adjourned to the certification hearing.


